Dear Dr. Zimmerman:

At its April 2024 meeting, the IACBE Board of Commissioners considered your request for the accreditation of the business programs offered by the School of Business and Technology at Aspen University. I am pleased to report that the Board of Commissioners approved your request and granted first-time specialized accreditation to the business program(s) as identified in the "Business Programs" table below, accompanied by the following note(s) and observation(s).

Notes are an indicator that while the program is in compliance with the Principles, additional monitoring is warranted. The School of Business and Technology is required to take action as specified below and respond to the IACBE *no later than June 29, 2024* (unless another due date is indicated within the Note). ### **Principle 2: Quality Assessment and Advancement**

Provide a revised Outcomes Assessment Plan, including updated rubrics, surveys, and other assessment instruments as needed. The following items are to be addressed along with any other areas that the school identifies as needing revision.

- 1. Ensure that the assessment instrument and the rubrics are clearly aligned to the outcomes.
- 2. Rewrite the OAP to measure one outcome per ISLO. For example:
  - Update BSBA ISLO #1 to choose between "business management skills" and "professional administration"
  - Update BSBA ISLO #3 "foster improvements in management systems, processes, and organizations"
  - Replace BSBA ISLO #4 with the text reflected as ISLO #4 on the Addendum.
  - MBA ISLO #3 addresses the business environment whereas the rubric specifies only the internal organization perspective. Update the rubric to also address the business environment.

### **Observations**

Observations are suggestions for further quality enhancements that the Board of Commissioners believes would be helpful for you in achieving excellence in business education but are not required for compliance with the IACBE's Accreditation Principles. Action on observations is optional, and reporting is not required.

The Board of Commissioners recommends the business unit review the wording in the following rubrics:

- MBA ISLO #2 for "exceeds expectations" may have a typo that should read "detailed and conscientious review of raw survey data".
- MBA ISLO #3 for "exceeds expectations" may have a typo that should read "detailed and conscientious review of root cause".
- MBA ISLO #4 for "exceeds expectations" may have a typo that should read "detailed and conscientious review of root cause".
- The "does not meet" column on BSBA rubric should reflect "undergrad" instead of "grad".

Accreditation represents a continuing relationship between an institution and its accrediting organization. Specialized program accreditation by the IACBE is dependent upon your institution remaining (i) in good standing with your institutional accrediting body and (ii) in compliance with the IACBE's Accreditation Principles and Policies.

As a reminder, within 30 days of the date of this letter, those granted First-Time accreditation are required to come into compliance with the two IACBE annual reporting requirements: update and publish the Public Disclosure of Student Achievement, and submission of the WebPath Notification form.
