At its December 2022 meeting, the IACBE Board of Commissioners considered your request to extend the accreditation period for the business programs offered by the School of Business at Avila University. I am pleased to report that the Board of Commissioners approved your request.

Accreditation represents a continuing relationship between an institution and its accrediting organization. Specialized program accreditation by the IACBE is dependent upon your institution remaining (i) in good standing with your institutional accrediting body and (ii) in compliance with the IACBE's Accreditation Principles and Policies.

Your Extended Approved Period of Accreditation is: 1/1/2018 – 12/31/2025
