Commendations

- 1. The Board of Commissioners commends the College of Professional Studies and Advancement and the university for the focus on social responsibility throughout the strategic plan. It is also visible in the program initiatives such as PACE, the recruitment strategy for high school students, and the tuition model for the undergraduate programs used to reach the under-represented populations.
- 2. The Board of Commissioners commends National Louis University for the strong commitment to supporting their students' career aspirations. This is evidenced in the participation in the Parker Dewey Program and the internships provided. Faculty commitment was also evidenced throughout the site visit.
