- 1. Please review all KLOs and their link to each ISLO and revise the OAP. Please ensure that a substantial number of the KLOs are linked to your ISLOs for all programs. As examples:
 - a. How are "teamwork" and KLO "leadership" linked to ISLO #3?
 - b. How is presentation of accounting materials (as stated in ISLO #3) measured by the Peregrine exam? If this is not measured by the exam, please determine a direct measure for this ISLO or reword ISLO #3.
- 2. The target/criterion for the indirect measure should read "somewhat agree" or higher. Please revise for all programs in which this indirect measure is used.

For the Associate of Science in Business Administration:

- 3. Please ensure that the KLOs are linked to your ISLOs. As examples:
 - a. How is KLO "analytical tools" linked to ISLO #1.
 - b. How is KLP "teamwork" linked ISLO #2?

- 4. The target/criterion refers to a scale using the word "agree". The rubric uses terminology of "successful". Please revise the target/criterion to match the actual scale used. Please revise for all programs that use the business internship as a direct measure.
- 5. Review/revise the assessment of the internship/field experience for clarity. Currently it sounds like the student will complete the assessment and not the supervisor of the internship.
- 6. Include all assessment instruments and rubrics in the back of the OAP.

Please provide a revised OAP by October 15, 2019 and provide data associated with the revised OAP in the current reporting format by October 15, 2020.

7. Please complete a credentials justification for Dr. Signorelli to teach the specific health care management courses to which he has been reassigned.

Observations
