The IACBE Board of Commissioners met on July 12-13, 2016 to consider your request for the reaffirmation of accreditation of the business programs offered by the School of Business, Arts, and Sciences and the School of Graduate and Adult Education at American International College. I am pleased to report that the Board of Commissioners approved your request and granted accreditation to your business programs accompanied by the notes and commendations identified below.

In granting accreditation, the Board of Commissioners is requiring the School of Business, Arts, and Sciences and the School of Graduate and Adult Education to host a commissioner's follow-up visit in the fall of 2019 in order to validate that the issues identified in the notes have been satisfactorily addressed, or that sufficient progress is being made in addressing the notes.

- Prof. Stimpson Please provide a justification for Prof. Stimson to be qualified to teach in the area of MIS. This justification could include MIS-related graduate courses taken, certifications held, professional experience, scholarly or professional publications, professional development in the area, and teaching experience.

Please submit a detailed plan and timeline for the implementation of the revised faculty evaluation process by November 1, 2016. Once the timeline is received, the IACBE will identify specific dates for the college to submit evidence that the plan is being implemented and the college is adhering to the timeline.
