The IACBE Board of Commissioners met on December 5-7, 2017 to consider your request for the accreditation of the business programs offered by the Department of Business Administration at Edward Waters College. Notes

Notes represent areas in which the Department of Business Administration is not in full compliance with the IACBE's Accreditation Principles. The department is required to take action on the notes as specified by the IACBE Board of Commissioners, and until the issues identified in the notes have been satisfactorily addressed, the progress made in complying with the commissioners' requirements as stipulated in the notes must be reported each year to the IACBE. Principle 1.1: Outcomes Assessment

Please provide a revised outcomes assessment plan that includes the following:

- 1. Provide a copy of the Separate Exit Survey that will be introduced and indicate in the outcomes assessment plan which intended student learning outcomes are being measured by the survey.
- 2. Provide a mapping of the Broad-Based Student Learning Goals and the Key Learning Outcomes for Bachelor's-Level Business Programs to the intended student learning outcomes for the five

concentration areas.

3. Provide a mapping of the intended student learning outcomes for the five concentration areas to the direct and indirect measures being used. Clearly state which concentration outcomes are being measure by each tool.

Once you have completed your revisions, submit a copy of the new outcomes assessment plan to the IACBE by March 30, 2018

Principle 3.2: Common Professional Component

It appears that courses for various concentrations have been included in the current table. These are not required of all concentrations. In lieu of this revision, separate tables that include all business courses could be provided for each concentration if preferred.
