The IACBE Board of Commissioners met on December 5-7, 2017 to consider your request for the accreditation of the business programs offered by the Ross College of Business at Franklin University. I am pleased to report that the Board of Commissioners approved your request and granted accreditation to your business programs accompanied by the note, observations, and commendation identified below.

Notes

Notes represent areas in which the Ross College of Business Unit is not in full compliance with the IACBE's Accreditation Principles. The department is required to take action on the notes as specified by the IACBE Board of Commissioners, and until the issues identified in the notes have been satisfactorily addressed, the progress made in complying with the commissioners' requirements as stipulated in the notes must be reported each year to the IACBE. Principle 1.1: Outcomes Assessment

Please provide a revised outcomes assessment plan that includes the following:

- 1. Ensure that all performance objectives are written to measure each of the intended student learning outcomes that they are mapped to. For example, the Peregrine examination is used to measure objectives 1, 2, and 3. The performance objective does not indicate that results are collected for each of the objectives being measured. Review and revise the performance targets to provide results for each of the intended student learning outcomes that they are mapped to.
- 2. Submit the revised outcomes assessment plan and corresponding rubrics reflecting the exact names of the programs listed for accreditation.

Observations

Observations are suggestions for further quality enhancements that the Board of Commissioners believes would be helpful to the Ross College of Business in achieving excellence in business education but are not required for compliance with the IACBE's Accreditation Principles. Action on observations is optional, and reporting is not required.

The Board of Commissioners recommends that the Ross College of Business review the adjunct pay structure to ensure that the pay is adequate to attract and retain high-quality faculty.
