The IACBE Board of Commissioners met March 30-31, 2020 to consider your request for the previous Deferral of Accreditation action on your request for the accreditation of the business programs offered by the Swiss School of Management. I am pleased to report that the Board of Commissioners approved your request and granted specialized accreditation to the business program(s) as identified below, accompanied by the following note(s) and observation(s).

#### **Background Information**

## **Principle 1.1: Outcomes Assessment**

1. Ensure that the language used in the intended student learning outcomes (ISLOs) and performance objectives is aligned with the language used in the related assessment measures. The language should be as consistent as possible between the ISLO and the measures. For example, for direct measures in the BBA program, the performance objective is X% will be evaluated as "competent/good" while the rubrics do not have "good" as a level

of performance (this is the case for every program). As another example, for the indirect measure Student Satisfaction survey, the performance objective is that 70% will be "more than satisfied" but the rubric items reference levels of success, rather than satisfaction. (This is the case for every program).

- 2. Revise the outcomes assessment plan (OAP) to include at least one direct measure for ISLO #7.
- 3. Revise the rubrics for the BBA dissertation and Viva Voce as they list one criterion for 3 ISLOs (2, 3, 4). Each ISLO must be measured separately.
- 4. Revise the performance descriptors in the BBA Thesis Evaluation Rubric to correspond to the criterion in the right two columns. For example, the research objective descriptors are the problem definition descriptors, and this continues across the rubric for each criterion.
- 5. Revise the Dissertation Evaluation Rubric Form for the DBA program, as it lists one criterion, "Content", as a measure for ISLOs #1 and #5. Each ISLO must be measured separately.
- 6. Revise the OAP as DBA- ISLO #3 is only measured once. Each ISLO must be measured at least once by a direct measure and a second time by a direct or indirect measure.
- 7. Revise the Dissertation rubric as it does not measure ISLO #5.
- 8. Revise the OAP for the PhD to include a second measurement for ISLOs #4 & #5.
- 9. Revise the Thesis Evaluation Rubric Form to differentiate among bachelor's-level, master's-level and doctoral-level performance. The performance expectations should be different for each level.
- 10. Provide a mapping of the survey items intended to measure intended operational outcome (IOO) #1 related to student satisfaction with teaching and advising. The specific survey items that relate to satisfaction with teaching and advising should be identified, since not all nine questions are related to teaching and advising in that section of the survey (for all programs).
- 11. Provide performance objectives and (targets/criteria) for IOOs #2 & #3.
