At its December 2022 meeting, the IACBE Board of Commissioners considered your request for the accreditation of the business programs offered by the School of Business and Accountancy at Holy Angel University. I am pleased to report that the Board of Commissioners approved your request and granted specialized accreditation to the business program(s) as identified in the "Business Programs" table below, accompanied by the following note(s) and observation(s).

- 3. Revise the mapping of the master's exit survey questions. For example, there is a note that states Part II #4 is related to faculty advising. However, advising is not a stated Intended Operational Outcome.
- 4. For each bachelor's, master's, and doctoral program, revise the performance objectives of each Direct Assessment Measure to be specific to individual student achievement of each ISLO being assessed; i.e., no overall grades, percentage scores, or marks are used. Instead, performance objectives should be expressed in terms of desired performance ratings on the specific performance criteria (rubric component) that is tied to the ISLO being assessed.; or in the case of objective-type comprehensive examinations, the performance objectives are expressed in terms of desired performance levels on each subset of examination questions associated with each ISLO being measured.

### Observations

Observations are suggestions for further quality enhancements that the Board of Commissioners believes would be helpful for you in achieving excellence in business education but are not required for compliance with the IACBE's Accreditation Principles. Action on observations is optional, and reporting is not required.
