At its July 2022 meeting, the IACBE Board of Commissioners considered your request to extend the accreditation period for the business programs offered by the Department of Entrepreneurial & Management Sciences at the Inter-American University of Puerto Rico-San German. I am pleased to report that the Board of Commissioners approved your request.

Accreditation represents a continuing relationship between an institution and its accrediting organization. Specialized program accreditation by the IACBE is dependent upon your institution remaining (i) in good standing with your institutional accrediting body and (ii) in compliance with the IACBE's Accreditation Principles and Policies.

Your Extended Approved Period of Accreditation is: - January 1, 2015 - December 31, 2023

Based on this approval, to be considered at the December 2023 Board of Commissioners meeting your site visit will need to occur no later than September 15, 2023. Please contact your liaison as soon as possible to schedule the site visit.

- Your Self-Study year will be: 2020-21
- 120 days prior to the start of the site visit – Draft Self-Study due
- 60 days prior to the start of the site visit – Final Self-Study due
