At its July 2024 meeting, the IACBE Board of Commissioners considered your request for the accreditation of the business programs offered by the International School of Business. I am pleased to report that the Board of Commissioners approved your request and granted first-time specialized accreditation to the business program(s) as identified in the “Business Programs” table below, accompanied by the following note(s) and observation(s).

### **Notes**

### **Observations**

1. The direct measures of student learning in each program must have accompanying evaluation rubrics with performance criteria that are directly and explicitly tied to evaluation of the ISLO being assessed. Revise rubrics (capstone and end of studies) so that they specifically identify the ISLO to be measured.

Additionally, upon completion of the review the Board of Commissioners voted to not require an on-site follow-up visit.

Specialized program accreditation by the IACBE is dependent upon your institution remaining (i) in good standing with your institutional accrediting body and (ii) in compliance with the IACBE's Accreditation Principles and Policies.

**Your Approved Period of Accreditation is: July 31, 2024 – July 31, 2031**

In addition to the annual compliance reports, all accredited members of the IACBE are required to submit an Interim Quality Assurance Report (IQAR) during their period of accreditation.
