Dear Dr. Cordova:

At its April 2023 meeting, the IACBE Board of Commissioners considered your request for the accreditation of the business programs offered by the College of Business and Accountancy at the Our Lady of Fatima University. I am pleased to report that the Board of Commissioners approved your request and granted first-time specialized accreditation to the business program(s) as identified in the "Business Programs" table below, accompanied by the following note(s) and observation(s).

Notes

Notes are an indicator that while the program is in compliance with the Principles, additional monitoring is warranted. The College of Business and Accountancy is required to take action as specified below and respond to the IACBE by July 10, 2023 (unless another due date is indicated within the Note). Principle 2.1: Outcomes Assessment

Please address the following items along with any other areas that the school identifies as needing revision.

- 1. The Intended Student Learning Outcomes (ISLOs) are to be program-level outcomes, not course-level outcomes (i.e., they clearly describe what students are expected to know and be able to do at the conclusion of the program, not at the end of a course), and therefore student achievement must be measured at the end of the program.
 - a. Exams used to measure ISLO #1 are currently given in the first year and are based on concentration skills and expertise rather than general business knowledge. Revise the timing of the exam to be given at the end of the program and use one exam to gather assessment results. Because the business unit has identified ISLO #1 as being linked to the IACBE Key Learning Outcomes #4 (general business knowledge), ensure that the questions assess general business knowledge.

- 2. Please specify whether the internship assessment (supervised work experience) occurs after the first or second work experience and confirm that an internship is required for all students.
- Intended Operational Outcomes (IOOs) should clearly describe the specific desired objectives of the business unit. They should be measurable and clearly identify what the business unit will do or provide.
 - a. For IOO #1, please indicate the target enrollment and retention rate (80% of what?) and ensure the report used for this data includes both rates.
 - b. For IOO #2, include questions #3, 4, and 5 to fully assess the operational outcome.
 - c. Clarify the performance objective for IOO #4 so that it aligns with and measures curriculum changes and growth.
 - d. For IOO #6 revise the performance objective to indicate the percentage of increase or amount targeted instead of "conduct more."

Observations

Observations are suggestions for further quality enhancements that the Board of Commissioners believes would be helpful for you in achieving excellence in business education but are not required for compliance with the IACBE's Accreditation Principles. Action on observations is optional, and reporting is not required.

- 1. If students in each concentration have the same set of core business courses, the business unit might consider developing the OAP based on the Bachelor of Business Administration core instead of developing separate tables for each concentration.
- 2. Since the feasibility study and the internship (supervised work experience) provide direct measures of all ISLOs in each Bachelor's level program, you may consider removing the exams as a direct measure. The use of exams could continue to provide the academic business unit data on student learning outcomes but would not be reported as part of the accreditation assessment. If the exams will be used for accreditation assessment, please comply with note #1 above.

Accreditation represents a continuing relationship between an institution and its accrediting organization. Specialized program accreditation by the IACBE is dependent upon your institution remaining (i) in good standing with your institutional accrediting body and (ii) in compliance with the IACBE's Accreditation Principles and Policies.
