Dear Dr. Gochenouer:

At its July 2023 meeting, the IACBE Board of Commissioners considered your request for the accreditation of the business programs offered by the Department of Business Innovation and Strategy at Southwest Minnesota State University. I am pleased to report that the Board of Commissioners approved your request and granted first-time specialized accreditation to the business program(s) as identified in the "Business Programs" table below, accompanied by the following note(s) and observation(s).

Notes

Notes are an indicator that while the program is in compliance with the Principles, additional monitoring is warranted. The Department of Business Innovation and Strategy is required to take action as specified below and respond to the IACBE by September 11, 2023 (unless another due date is indicated within the Note). Excellence in business education is demonstrated when the academic business unit is engaged in a process of continuous improvement in its programs and operations. This process includes assessment planning, collection and analysis of assessment data, and development and execution of action plans for improvements.

Provide a revised Outcomes Assessment Plan (OAP), including relevant rubrics, surveys, and other assessment instruments. The following items are to be addressed along with any other areas that the school identifies as needing revision.

 The Intended Student Learning Outcomes (ISLOs) are to be measurable statements of outcomes that are observable and evaluated for each individual student. For example, the MBA program includes ISLO #1 "Students will *acquire* knowledge ..." and ISLO #5 "Students will be *fully cognizant* ..." neither of which are observable or measurable. - 2. Assessment Measures must clearly and directly evaluate the ISLO(s) it is intended to measure.
 - a. The Student Learning Portfolio does not clearly identify which performance criteria are linked to the direct evaluation of the ISLOs they are intended to assess. Provide a revised portfolio that clearly identifies the direct evaluation of the ISLO(s) being assessed.
 - b. The MBA Capstone Case Study Rubric does not clearly identify which performance criteria are linked to the direct evaluation of the ISLOs they are intended to assess. Provide a revised capstone rubric that clearly identifies the direct evaluation of the ISLO(s) being assessed.
- 3. Comprehensive exams must contain required components (a subset of questions) that directly evaluate the ISLO(s) being assessed. Provide a description of the MBA comprehensive exam that identifies the subsets of questions that directly evaluate each of the ISLOs being assessed by the exam.
- 4. Ensure the revised OAP reflects the current Intended Operational Outcome (IOO) statement #4 (regarding faculty scholarship and professional development). There were two different versions of IOO #4 in the OAP, with one on page 71 of the OAP relating to the awarding of a stipend and the second on page 72 relating to faculty scholarly activity. The assessment measure, as indicated on page 72, pertains to faculty scholarly activity.

Observations

Observations are suggestions for further quality enhancements that the Board of Commissioners believes would be helpful for you in achieving excellence in business education but are not required for compliance with the IACBE's Accreditation Principles. Action on observations is optional, and reporting is not required.

No observations were identified by the Board of Commissioners.

Additionally, upon completion of the review the Board of Commissioners voted to not require an on-site follow-up visit.

Accreditation represents a continuing relationship between an institution and its accrediting organization. As a reminder, within 30 days of the date of this letter, those granted First-Time accreditation are required to come into compliance with the two IACBE annual reporting requirements: update and publish the Public Disclosure of Student Achievement, and submission of the WebPath Notification form.

- Each Academic Business Unit must publicly report at least one IACBE-approved student achievement measure on an annual basis for each IACBE accredited program.
