Dear Dr. Sangdel:

At its July 2024 meeting, the IACBE Board of Commissioners considered your request for the accreditation of the business programs offered by the Faculty of Management Sciences at Swiss UMEF. I am pleased to report that the Board of Commissioners approved your request and granted specialized accreditation to the business program(s) as identified in the "Business Programs" table below, accompanied by the following note(s) and observation(s).

## <u>Notes</u>

Notes are an indicator that while the program is in compliance with the Principles, additional monitoring is warranted. The Faculty of Management Sciences is required to take action as specified below and respond to the IACBE *no later than October 14, 2024* (unless another due date is indicated within the Note). Responses must be submitted via the online platform available on our website: <u>www.iacbe.org/reports-note-compliance.asp</u>. All documents must be provided in English.

### **Principle 2: Quality Assessment and Advancement**

1. Direct and indirect measures of intended student learning must directly link to the achievement of specific Intended Student Learning Outcomes (ISLOs). Revise performance objectives to reflect the achievement of the ISLOs. For example, The Performance Objective in the Bachelor of Science in Business Administration states: "80% of senior students in the FMS will defend successfully their dissertation or internship report." Defense is not a learning outcome. Restate the Performance Objectives to align with the assessment rubrics. For example, a revision might state: "80% of senior students will have a score of (3) Proficiency or (4) High Proficiency on the rubric criterion for each ISLO assessed."

### **Observations**

Observations are suggestions for further quality enhancements that the Board of Commissioners believes would be helpful for you in achieving excellence in business education but are not required for compliance with the IACBE's Accreditation Principles. Action on observations is optional, and reporting is not required.

### **Principle 2: Quality Assessment and Advancement**

 Each intended student learning outcome must be assessed by at least two different assessment measures, at least one of which must be a direct measure. A second indirect measure is not required. However, the Alumni Surveys were not included in the Outcomes Assessment Plan Appendices. If the business unit chooses to use this for assessment, it should be directly mapped to the Intended Student Learning Outcomes in the same manner as the Exit Survey.

Additionally, upon completion of the review the Board of Commissioners voted to not require an on-site followup visit.

Accreditation represents a continuing relationship between an institution and its accrediting organization. Specialized program accreditation by the IACBE is dependent upon your institution remaining (i) in good standing with your institutional accrediting body and (ii) in compliance with the IACBE's Accreditation Principles and Policies.

# Your Approved Period of Accreditation is: January 1, 2025 – December 1, 2031

In addition to the annual compliance reports, all accredited members of the IACBE are required to submit an Interim Quality Assurance Report (IQAR) during their period of accreditation.
