Dear Dr. Naceur Azaiez:

At its July 2024 meeting, the IACBE Board of Commissioners considered your request for the accreditation of the business programs offered by the Tunis Business School at the University of Tunis. I am pleased to report that the Board of Commissioners approved your request and granted first-time specialized accreditation to the business program(s) as identified in the “Business Programs” table below, accompanied by the following note(s) and observation(s).
