Dear Dr. Lopez:

At its December 2022 meeting, the IACBE Board of Commissioners considered your request for the accreditation of the business programs offered by the College of Business Administration at the University of the Southwest. I am pleased to report that the Board of Commissioners approved your request and granted first-time specialized accreditation to the business program(s) as identified in the "Business Programs" table below, accompanied by the following note(s) and observation(s).

# **Notes**

Notes are an indicator that while the program is in compliance with the Principles, additional monitoring is warranted. The College of Business Administration is required to take action as specified below and respond to the IACBE by March 8, 2023 (unless another due date is indicated within the Note). ### **Principle 2.1: Outcomes Assessment**

- 1. Revise exit surveys to more explicitly identify linkage to ISLOs each survey item is assessing.
  - a. This may be accomplished by using the exact Intended Student Learning Outcome (ISLO) wording to ensure clear. For example, the MBA program survey (see pg. 204 of the self-study) uses words that appear to link to the ISLOs but does not explicitly do so.
- 2. Revise exit surveys to ensure that they are assessing individual student achievement specific to each ISLO.
  - a. For example, the doctoral program survey on pg. 208 of the self-study lists the exact ISLO wording but then asks for student perception of outcomes achievement collectively, rather than assessing outcomes achievement of each ISLO individually.

#### **Observations**

Observations are suggestions for further quality enhancements that the Board of Commissioners believes would be helpful for you in achieving excellence in business education but are not required for compliance with the IACBE's Accreditation Principles. Action on observations is optional, and reporting is not required.

No observations were made by the Board of Commissioners.

Additionally, upon completion of the review the Board of Commissioners voted to not require an on-site follow-up visit.

Accreditation represents a continuing relationship between an institution and its accrediting organization. As a reminder, within 30 days of the date of this letter, those granted First-Time accreditation are required to come into compliance with the two IACBE annual reporting requirements: update and publish the Public Disclosure of Student Achievement, and submission of the WebPath Notification form.

- Each Academic Business Unit must publicly report at least one IACBE-approved student
  achievement measure on an annual basis for each IACBE accredited program. The disclosure
  must include results, and the business unit's expectation for those results, from the most
  recently concluded academic year. A template to the student achievement disclosure form is

- 2. Once the updated disclosure is posted to your website, you are required to submit the Web Path Notification Form that informs the IACBE of the path that a member of the general public would take to get to 1 the updated Public Disclosure of Student Achievement, and 2 any statement of IACBE-accreditation published on the institution's website.
