At its December 2022 meeting, the IACBE Board of Commissioners considered your request for the accreditation of the business programs offered by the Department of Management at Vaughn College of Aeronautics and Technology. I am pleased to report that the Board of Commissioners approved your request and granted specialized accreditation to the business program(s) as identified in the "Business Programs" table below, accompanied by the following note(s) and observation(s).

Notes
