### IACBE Region 7 Conference Speaker Bios

"Deep Approaches to Student Learning"

#### **Bethany Blankenship**, Ph.D.

Bethany Blankenship is an Associate Professor of English at the University of Montana Western. Blankenship's research on teaching and learning can be read in the books "The MLA Guide to Approaches" to Teaching The Canterbury Tales and "Linked Courses for General Education and Integrative Pedagogy."

#### Christian Gilde, Ph.D.

Christian is an Assistant Professor of Business at the University of Montana Western. He conducts research in the areas of marketing, consumer culture, and organizational sociology. His teaching interests include marketing, management, and operations management. He serves as a reviewer for journals such as the Journal of Consumer Behaviour and the Southwest Teaching and Learning Journal.

#### Kurt Steadman, J.D.

Kurt is currently an Assistant Professor of Business at the University of Montana Western. He has been teaching at the University of Montana Western for approximately three years. Prior to coming to the University of Montana Western, he practiced law for various years and also owned a residential construction business.

#### Erik Guzik, Ph.D. "Moving from GPA to BSI (Business Skills Index)

Erik is an Associate Professor of Economics in the Department of Business and Technology at the University of Montana Western. He is also the founder of Vast Learning Systems, an educational technology company focusing on the development and assessment of advanced cognitive skills. He has received numerous grants to study the development and measurement of student learning outcomes. For his research into new, software-based assessment tools, Dr. Guzik received the 2011 Creative Oklahoma Great Inspirations Award, the Oklahoma Journal Record's 2012 Creativity Award, and Hewlett Packard's 2012 Catalyst Showcase People's Choice Award. His current research centers on creative economies and IT-based creative problem solving methodologies. Dr. Guzik is currently spearheading an effort to assess the creative and problem-solving abilities of students throughout the United States in order to better understand new methods of measuring and promoting student creativity in the classroom. He is also leading research to develop new tools to promote and assess experiential learning within online environments.

### Jill Thomas-Jorgenson, M.A.-"You-Tube, Lectures, Handouts – How do student's best learn?"

Jill Thomas-Jorgenson teaches at Lewis-Clark State College (LCSC) in Lewiston, Idaho. She taught as an adjunct for the Business Division at LCSC from 2002 – 2011. She now serves as an Assistant Professor for the Division. She primarily teaches the capstone courses in business strategy, but also teaches marketing. She has owned her own businesses and enjoys encouraging other small business owners. Jill spent almost 12 years with the Region II Idaho Small Business Development Center (SBDC) also at LCSC as the Director. In her role at the SBDC, she worked with over 100 clients each year counseling them in the areas of management and organization, marketing, and financials. Much of her work involved assisting her clients as they developed business and strategic management plans for their businesses. She earned her Bachelor of Science Degree from LCSC in Communication Arts, and her Master of Arts Degree in Organizational Leadership from Gonzaga University in Spokane, Washington.

### Laura Gow-Hogge, Ph.D. Moving toward Inclusion: A Discussion of Technology Issues for Visually Impaired Students"

Laura is an Associate Professor of Business with the College of Business at Eastern Oregon University and has been teaching higher education for 13 years. She currently severs as the chair of the College's curriculum committee and as their representative to the University's curriculum council. She is responsible for delivery approximately 10 different courses in the business curriculum on-campus, online, and on-site. Course areas include marketing, management, finance, ethics, leadership, human resources, and entrepreneurship. She is also the lead faculty for the curriculum development and course delivery of the Agribusiness concentration.

Her focus area is supply chain marketing and management and niche marketing. She has worked on projects with the "Got Milk" and "Pork the Other White Meat" campaigns and developed the first certified natural beef program in the US. Her PhD dissertation focused on the impacts of regulations on corporate hog farming. She has also looked at rural health care issues and the impacts of tax rates. Recent research projects have included feasibility analysis and marketing and business plans for various tribes in Oregon as well as conducting a regional educational needs assessment. Current research interests include student preferences, experiences, and access to technology.

**Gary Railsback**, **Ph.D. & Dave Quirk**, **MBA-**"*Implementation of a web-based assessment system that meets both NWCCU and IACBE assessment requirements.*"

Gary is the Associate Vice President for Academic Affairs, Dean of the School of Professional Studies, Professor of Education and Management. Gary returned to his alma mater (NCU) in 2013 after a 27 year career in higher education. His current position involves supervising all degree programs in Business, Teacher Education, Graduate Counseling and the Adult Degree Programs in Psychology, Criminal Justice and Interdisciplinary Studies. His doctoral dissertation from UCLA focused in higher education issues of faith and learning, and his recent MBA from Point Loma Nazarene University focused on Responsibility Center budgeting for Deans in Business, Education and Nursing.

Dave Quirk arrived at NCU in 2012, but had been an active Adjunct Instructor with NCU since 2006. His primary teaching schedule includes management, strategic management, human resource management, computer sciences, and numerous other businessbased disciplines. He brings over 25 years of teaching expertise to the classroom.

Lieutenant Commander Quirk spent 22 years in the U.S. Navy: 4 years enlisted and 18 years as an officer. Of the latter, he was an Operations Officer on both a US Frigate and Cruiser, and a Commanding Officer of two Navy Reserve Centers here in Oregon. Dave also spent 4 years as an environmental services manager to two remote facilities and was responsible for over \$1.5 million in revenues. As a Faculty Instructor in the Undergrad, Adult Studies, and MBA curriculums, and a former Vestry Member of St Matthew's Episcopal Church in Eugene as the Junior Warden, Dave stays busy but always has time to talk business "shop" with his students.

**Julia Underwood**, **Ph.D**.-"Embracing the pieces of diversity in the development of character in our students: Approaching implementation and measurement."

Julia is a Professor in the School of Business and Management at

Azusa Pacific University. In addition to teaching, she actively engages the immediate and larger university community in faculty governance, serving two consecutive elected terms as Faculty Moderator at the university providing opportunity to collaborate with administrative, staff and student groups. Her commitment to higher education is additionally evident in her work with external constituent groups. She has board level posts within Christian Business Faculty Association and the International Assembly for Collegiate Business Education. These leadership positions are purposefully intended to strengthen the intellectual and social development of students, thereby impacting the organizations of tomorrow and society at large.

Dr. Underwood pursues research and consulting in conjunction with her service to organizations and the community by addressing issues of: customer service and customer satisfaction measurement, faith integration within the undergraduate experience and gender issues.

### **Terrie O'Brien, MBA-** *"The Traveling Classroom: Experiential learning on the go."*

Terrie has been teaching Marketing for 28 years. She is currently an Associate Professor of Marketing at the University of Guam, and while living in Australia taught Marketing at Monash University in Melbourne for three years, where she undertook doctoral studies in Services Marketing Management. She received her Bachelor's degree in Psychology from California State University, Fullerton and her Master's in Business Administration with a double major in Marketing and Finance from University of California, Los Angeles. After graduation she worked in advertising with Doyle, Dane, Bernbach, New York, then ran a small telecommunications company in California. After moving to Guam, 28 years ago, she began providing consulting services in Marketing Management and Market Research for both local and international companies and continues this today. Her areas of interest and teaching include Marketing

Management, Marketing Research, and e-Marketing. She has also worked on various projects for the University such as accreditation coordinator, department chair, internship coordinator, marketing club advisor, and promotional development. She has worked in retailing, banking, promotions, and sales. She enjoys traveling and has traveled extensively throughout the U.S., Europe, and Asia.
